Gebo opened the meeting at 7:00 pm, the reading of the public hearing was waived.

I. BV1-23, BV2-23 Area Variance, property located at 28 Page Place, in the Village of Bloomfield Owner Nicholas George tax # 67.19-1-77.200 is applying for an Area Variance to erect a 24 x 40 Personal Storage Pole barn in front of his SF home and a side setback Area Variance, barn will sit 8ft. at the closest point where 10 ft. is required.

George stated he is asking for 2 variances, one to place a structure in front of his Single-Family home and one for the side. George would like to build a Pole Barn on the North side of his property to use for storage. George stated that the property is wet on the side where he wants to place the barn but, the other side is his lawn and directly in front of his house so, this is the best location for the pole barn.

Gebo stated it looks pretty straight forwarded. Bowe asked if we had received a letter from Sullivan. Rayburn stated Sullivan provided a letter before leaving for Florida stating he had no issues with the placement of the barn. Gebo asked the Board for any further comments, there were none.

Gebo motioned to close the public hearing, Bricco Seconded, all Board members present voted aye.

The Board then started their review of the State mandated five (5) criteria tests.

- 1. <u>Undesirable change to the neighborhood:</u> They find that this proposal will not be an undesirable change.
- 2. Alternative method: This is the best location for the applicant, and it does not cause any issues or concerns.
- **3. Substantiality:** The Board feels that this proposal is not considered substantial.
- 4. Impact on the environment: none
- 5. **Self-creation:** Yes

Gebo motioned to declare SEQR a type II, no further action required.

Bowe made a motion Wollschleger seconded to approve, to grant the 2 ft. area BV1-23, BV2-23 Area Variance, property located at 28 Page Place to erect a 24 x 40 Personal Storage Pole barn in front of his SF home and a side setback Area Variance, barn will sit 8ft. at the closest point where 10 ft. is required.
